The Event

For 1 month, JOYA offers artists, students, groups and galleries a new space where they can display their latest creations and increase their contact list. The event is organized by Le Département Interiors S.L and is directed by Paulo Ribeiro.

Eligibility

Professional individual artists working in the field of jewellery and crafts as well as artists from other fields of art and design that focus on the new ideologies and aesthetic views of art jewellery and art objects are eligible to participate in JOYA.

Candidates from all countries and nationalities will be eligible to participate in the exhibition. There are no restrictions regarding material, size and concept of the pieces, however, no brand names will be represented. To be eligible to participate, the artist should be properly registered as a self-employed worker in the Social Security system or be part of a company for taxation purposes.

Selection

A jury according to the following criteria selects the participating artists in JOYA: originality and innovation of designs, concept, material use, craftsmanship and coherence under a theme or research line. The selection of the artists who will be participating to JOYA 2021 will be officially divulgated by e-mail on May 30th, 2021.

Awards

Athens Jewellery Week: Erato Kouloubi and Niki Stylianou will select an artist to participate in the next edition of AJW, Greece.

Arte y Joya: It is an award given every year to the designer of the winning work of the contemporary jewellery yearbook Arte y Joya. Of all the participants who register and hang on our website there will only be 32 designers selected to be part of the printed yearbook. Of those 32 finalists, the jury will choose a winning work that will take the award during the Joya Barcelona.

DOR Museum: The museum will reward the artist selected with the acquisition of one of his pieces for the permanent collection of the museum.

Myday byday Gallery: The gallery will reward the selected artist with an exhibition in the gallery located in Italy.

Brazil Jewellery Week: An artist will be awarded with a free participation in the next edition of the event in Brazil.

Alice Floriano FIO Gallery: An artist will be awarded with a solo exhibition at the Brazilian gallery.

Special Collaborations

SCHMUCK: Winners of SCHMUCK and TALENTE 2021 are invited to be part of individual artist space at JOYA.

Gioielli in Fermento (Jewellery Fermentation): the latest edition awarded artists will exhibit an individual collection within GiF#gallery & Allied Group, an international collaboration with its heart rooted in Val Tidone. (Italy).

AdOC "Asociación de Diseñadores de Orfebrería y Joyería": Winners of AdOC will be invited to JOYA, as well the selected artists by them will be part of the exhibition in Madrid.

General Terms and Conditions

JOYA Barcelona 2021 is organized by Le Département Interiors S.L. These terms and conditions apply to exhibitors participating in JOYA Barcelona, on site exhibition. The organization reserves the right to review these terms and conditions without notice.

Conditions to Admission

All exhibitors must provide a fully complete application package by the mentioned due date, information must be true and up to date. All complete applications will be reviewed the event holds the right to accept or decline any application. Decisions are final.

The applicant accepts that once the application is selected, this contract holds valid and both parts will be held in accordance to it.

The candidates accept that once selected by the jury, with a maximum term of May 30, 2021, the contract is valid and both parties commit to comply with it.

The artists must send the pieces to the JOYA showroom, after being notified as selected within a maximum period of 2 weeks. All transportation and insurance costs for the pieces will be held by the participants.

Participation fees must be completed until June 30, 2021.

All payments of the participation fee must be made by the date specified.

All shipping and transportation expenses for the exhibition will be covered by the participant(s).

JOYA reserves the right to correct or remove any material or product that is not suitable to the aim and conditions of the exhibition.

The participant agrees to the organization's use of photographs of the art material provided by the artists, as well as any taken during the fair, to be used in different media outlets, such as the web, catalogues, posters, magazines, video, etc.

Coaching

Participation package and space allocation

The location and distribution of space will be determined by the organization according to the physical characteristics of the space and its accessibility. In any case, the participating artist may promote any other artist, brand or event that has not been specified as part of the accepted application. JOYA Barcelona reserves the right to modify the layout plan of the space to comply with security regulations or in the case of exceptional cancellations.

Sales and commissions

The organization does not manage any relation into sales or commission between artists and potential customers. The use of invoices is obligatory and has to hold the regulations. It is the duty of artists and exhibitors comply with the regulations in case of selling while participating in the Fair. JOYA does not have a cash drawer or credit/debit card terminal for this purpose.

Legal information about metals

The manufacturer or importer has the legal obligation to make the pieces that manufactures or sells with two punches (origin and guarantee).

The retailer must also control and also is responsible for the presence of both parts in the acquired pieces. We insist once more: When pieces are offered for sale, seller is also responsible before the authorities and the consumer. Thus, there is always the obligation to require suppliers to furnish properly the punched parts, to avoid penalties; or alternatively, carry them to an official laboratory as the JORGC.

Insurance and liability

JOYA provides security for the hall 24 hours. However, it is the sole responsibility of the exhibitors to assume the risk of loss or damage. We recommend that participants insure all pieces against any theft, loss or damage that could arise during the event, including during any transportation or storage.

Cancellation and Reimbursement

The selection committee has the right to cancel any participation on the basis of false information or if the participant fails to comply to the criteria and dates specified.

Cancellation of contract by the participant holds a 100% penalty of the total value of the participation fee If it is notified after payment has been deposited. Reimbursements will not be issued unless JOYA Barcelona agrees in writing and responds to an exceptional case.
